The owners are Don and Jun.....Speaking of businesses in the neighborhood, as I am sure many have notices, there are new businesses in the area all the time. The Edgewater Chamber of Commerce now numbers over one hundred members. Much redevelopment is going on on Broadway, for instance. It is important that we, as residents of the area, help support these local businesses and this commercial redevelopment. Shop and dine in Edgewater.....The Officers and Block Representatives have been discussing an idea that has long been a topic of interest in the neighborhood: cul-de-sacs for Hood, Glenlake and Norwood at Broadway.
